Minutes of September 25, 2015 Business Meeting approved as distributed by e-mail.

Antenna Committee:

Paul KE6NVU reported that we dropped three towers:

- (1) The Gold Beach tower which went to Larry (the bottom 2 sections were welded instead of bolted together so it was not sellable.
 - (2) Marina Heights Loop which is the \$500 \$1500 crankup tower.
 - (3)Keusink's tower was badly rusted and had to be cut into sections to be removed.

Discussion of a possible price for one of the towers followed, because of interest from prospective buyers, former members of the club. MOTION by Butch KG7LIK "The negotiation will start at \$1500.00 with a \$500.00 minimum price." The motion was passed.

About repeaters: Two new machines were purchased. The second one that Paul KE6NVU purchased for us is installed on Habor Hills(146.96)

MOTION by Doug K7KY "Reimburse Paul KE6NVU for the second repeater." The motion was passed.

Surveying possible emergency transmission setup sites with the other repeater (146.84): One site facilitated by Brian KG7VJG is on a tower, 900 feet up, free power, but located in California. A possible second site is on Marina Heights Loop in Brookings at a private residence.

Bob W7VN described the equipment he has been using for testing sites, listening to the Tuesday net for stations, and suggested we use a standard test setup to properly compare prospective sites. When a location is chosen, there will be a written agreement with the site owner for understanding all around. Bob W7VN also pointed out the need for registration and re-coordination of the repeater (146.84) once it is situated.

Ron K7IOW mentioned in passing that the last emergency drill(Oregon Shakeout) revealed that contact with the Bosley Butte repeater (147.25) from the Catholic Church(94323 Gauntlett St, Gold Beach) did NOT work.

Paul KE6NVU mentioned (1)that Harry Bryant, who participated in the Oregon Shakeout with us from Port Orford, expressed interest in our Communications Training exercises, and (2) that Beth Hildago had mentioned our club involvement with the Medical Reserve Corps during the Oregon Shakeout to the county commissioners.
